#### CONTRACT PERIOD

Any consumer choosing to be served under this time-of-day schedule must remain on the schedule for at least one year, unless the consumer agrees to pay the Cooperative a fee of one hundred dollars (\$100) to cover the cost of exchanging the meter.

## WHOLESALE POWER COST ADJUSTMENT

The above charges per kWh will be increased or decreased by 0.001 cents per kWh or major fraction thereof, adjusted for line loss, by which the Cooperative's cost of purchased power per kWh exceeds or is less than the base cost of power shown in the Wholesale Power Cost Adjustment Clause.

# DETERMINATION OF ON AND OFF-PEAK PERIODS

For the period of April 16 through October 15, the hours are as follows:

On-Peak Hours: 2:00 p.m.-6:00 p.m., Monday - Friday, excluding those holidays as

designated by the Cooperative.

Super Off-Peak Hours: 10:00 p.m. - 5:00 a.m., All days of the week, including the

holidays designated below.

Off-Peak Hours: All other times.

For the period of October 16 through April 15, the hours are as follows:

On-Peak Hours: 6:00 a.m., Monday - Friday, excluding those holidays as

designated by the Cooperative.

Super Off-Peak Hours: 10:00 p.m. - 5:00 a.m., All days of the week, including the

holidays designated below.

Off-Peak Hours: All other times.

Designated holidays shall be New Year's Day, Good Friday, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and the day after, and Christmas Day.

#### TERMS OF PAYMENT

Bills are due when rendered and are payable within fifteen (15) days from the date of the bill. If any bill is not so paid, the Cooperative has the right to suspend service in accordance with its service regulations.

# SALES TAX

Any applicable State and local sales taxes will be added to all service billed under this schedule.
